

Tack Stalls

One tack stall consists of two ties. Only one tack stall allowed per family/address.

#### **Blocking Chutes**

\$25/chute - Limited to one chute per six head of cattle per family/address. Chute tags will be issued upon check in. Any chutes seen without tags will be asked to leave.

All fees shall be paid online by credit or debit card (Visa, Mastercard or Discover). Each transaction will have a 5% processing fee.

Late entries will only be accepted if all the following conditions are met:

- 1. Adequate exhibit space if available.
- 2. Late entries must be received by 5 PM on Tuesday, August 5.
- 3. The late fee equal to twice the total regular entry fee is paid in full.

**Feeding/Unloading Permit:** A feeding/unloading permit may be purchased at the State Fair Administration Office or online upon submission of livestock entry for \$20 (only 1 permit per family/address allowed). This permit allows entry on the fairgrounds before 9 AM and after 6 PM to feed animals and then exit immediately. This is NOT a parking permit and will be subject to towing if vehicle is left unattended for an extended amount of time. Permits are only valid during the designated hours.

**Refund Policy:** The fair may refund entry fees paid by an exhibitor if the exhibitor requests the refund in writing two weeks prior to the opening day of the fair and states the reason for requesting the refund. Following that timeframe, NO refunds will be issued.

#### CASH PREMIUM SCHEDULE

Prize money in each Beef Division will be paid on the following scale:

\$75 \$60 \$45 \$35 \$30

Divisions of 15 head or more may be split at the discretion of the superintendents.

Groups - Only one entry per division will be paid.

Supreme Champions: Supreme Champion Bull will receive \$1,000 cash prize and a semen collection sponsored by 605 Sires, Marion, South Dakota. Supreme Champion Female will receive a \$1,000 cash prize and a flush sponsored by BovaGen, Lake City, South Dakota (terms determined by sponsor).

To qualify for Supreme Champion competition, animal must win either Grand or Reserve Champion Bull or Grand or Reserve Champion Female in their respective breed division. Only the animal named Grand or Reserve Champion for that breed will qualify. If the Grand Champion for the breed is not present for the Supreme Champion competition, premiums will be forfeited for that animal (with exceptions due to family emergency or religion).

*Wilson Trailer:* All Grand Champion Breed exhibitors also qualify for the chance to win the use of a 24', three compartment trailer for one year: compliments of Wilson Trailer. Exhibitors of breed champions, excluding the two Supreme Champion winners, will play one hand of draw poker, one game for the bull exhibitors and one for the female exhibitors. The two winners of each hand will then play again for the use of Wilson trailer.

Yackley/Trans-Ova Genetics: Yackley/Trans-Ova Genetics will award all Breed Champions both Bulls and Females at the South Dakota State Fair Open Class beef shows a \$100 credit voucher at Trans-Ova.

*Herdsmanship Award:* The SD State Fair will award herdsmanship awards to the exhibitors who exhibit the qualities required to sustain a premier show including: cleanliness of stalls, general neatness in care of barns and livestock, and cooperation and courtesy throughout the entire show to other exhibitors and staff. Sponsored by Common Sense Manufacturing and The First National Bank in Sioux Falls.

#### **HEALTH REGULATIONS**

A completed Certificate of Veterinary Inspection, listing individual animal official identification must accompany all animals exhibited at the South Dakota State Fair. The Certificate of Veterinary Inspection must be issued within 30 days of entry to the State Fairgrounds. Certificates of Veterinary Inspection written for animals originating from outside the State of South Dakota must meet all state import requirements as listed on the SD Animal Industry Board website. The consignee must be listed as:

South Dakota State Fair, 1060 3rd St. SW Huron, SD 57350Notice: Certificate of Veterinarian Inspection (CVI) Collection Process is:

- 1) Exhibitor presents CVI to Livestock Superintendent, or their designee, at check-in to verify they have a CVI.

  NOTE: If exhibitor is showing multiple species, they need a separate CVI for each species.
- 2) Exhibitor gets stall assignment and is responsible for writing the stall number on the CVI and then puts the CVI in the CVI collection box.
- 3) AlB collects CVIs from the collection box several times throughout the day to inspect animals.
- 4) It is the exhibitor's obligation and responsibility to ensure their animal(s) are healthy and that they have obtained a CVI within 30 days of bringing the animal(s) onto the fairgrounds. Any exhibitor found bringing an animal with obvious issues pertaining to animal health and well-being will be asked to leave immediately and will not be allowed to show at the 2025 South Dakota State Fair.
- 5) Electronic CVIs will be accepted. Exhibitors may show their electronic CVI upon check in and fill out the provided form to file in the CVI collection box.

Animals must be free of signs of communicable and infectious disease at the time of entry onto the Fairgrounds. Any determination of the health status of an animal will be at the discretion of the State Veterinarian or official representative.

#### **QUIET TIME**

For safety purposes and security of livestock and personal property, the South Dakota State Fair has established a "Quiet Time" in all barns that starts at 2 AM until 5 AM. Large gatherings, parties or excessive socializing will be prohibited at that time. Thank you for your cooperation.

#### **U-FIT-IT CONTEST**

There will be two representatives from each breed holding a junior show at the South Dakota State Fair or Summer Spotlight, as well as representatives from FFA and 4-H. Those representatives will fit and show the animal used at selection time, unless otherwise approved by chairman prior to contest. Each breed adult advisor is responsible for their breed representatives. Each breed association will be responsible for a \$25/breed entry fee to cover judging expenses.

A belt buckle donated by Hubbard Milling, Watertown, SD and a new blocking chute donated by Sullivan Supply, Dunlap, IA will be awarded to the champion show person.

#### Rules:

- Cattle will be clean and dry with no adhesive, oil or other foreign substances.
- Chutes will be used.
- No helpers can be used.
- The use of Andis 2 or 5 speed clippers will be permitted. One clipper per contestant allowed.
- Age Limit: Minimum age 14 as of January 1 of current year. Maximum age 21 as of January 1 of current year.
- All exhibitors must be or have been members of SD 4-H or FFA and in good standing.
- Thirty minutes will be allowed to fit and groom the animal.

#### SD JUNIOR BEEF BREEDS FITTING CHALLENGE

The South Dakota Junior Beef Breeds Fitting Challenge was started in 2015 by Dave Stout. This is a team challenge open to juniors in each breed.

A \$1000.00 award will be presented to the winning team's Junior Association by J &R Distributing of Lake Norden, SD.

#### Rules:

- 1. Each breed will be allowed one team to compete in 2025.
- 2. Teams must include one senior (14-18), one junior (11-13), and one beginner (8-10) as of January 1, 2025, using the 4-H age guidelines.
- 3. If you are unable to fill your team spots from members of your breed organization, you will be allowed to have 1 team member from outside your breed organization. We ask that you first select participants that are members of your breed organization. This should ONLY be used as a last resort.
- 4. The method used to select your team is left up to each breed association.
- 5. A \$1000.00 award will be presented to the winning team's Junior Association by J &R Distributing of Lake Norden, SD.
- 6. The contest will take place Friday, August 29, 2025, at 6:00 p.m.
- 7. No team will be allowed to set up until notified by the announcer. Each breed needs enough help to get their team set up immediately following the conclusion of the Junior Points Show awards.
- 8. Chute placement will be posted in the DEX on Wednesday, August 27, 2025 by 5:00 p.m.
- 9. Your breed (team) is responsible for supplying their own electricity and any other items needed. The show will not stop because of loss of electricity.
- 10. There will be NO cell phones allowed by any team members during the competition. Please inform your participants.
- 11. Entries will be done electronically. Please submit your breeds entry at https://forms.gle/pCMseBRC4fehySHg9
- 12. Entries are due by Sunday, August 17, 2025, at 11:59p.m. The fee for your breed to participate is \$50.

#### **DEPARTMENT RULES**

- 1. All entries must be done online at <a href="https://sdsf.fairwire.com">https://sdsf.fairwire.com</a>, Entries must include exhibitor's name and address, cell phone number, social security number, or federal tax ID.
- 2. Animals registered in two breeds can only show in one breed.
- 3. Nurse cows will not be allowed.
- 4. No animal shall be entered in the name of any other than the proven owner or owners; and should any prove to be otherwise entered, premiums awarded will be forfeited.
- 5. The name of exhibitors, as printed on the entry blank, must correspond and be the same names as on the breed registration papers and W-9.
- 6. Chutes will only be allowed in the designated areas. Chute tags will be issued upon check-in. Any chutes seen without tags will be asked to leave. Tack stalls are \$90 and are limited to one per family/address. One tack stall consists of two ties. A tie is 3.3 ft. Will attempt to honor stalling request but cannot be guaranteed.
- All cattle must be on the grounds by 8 PM on Tuesday, August 26. All cattle will be checked in upon arrival in the DEX Atrium. Early
  check in will be available on Sunday from 1 PM 5 PM.
- 8. Once checked in, all cattle must remain in the immediate proximity of the DEX unless traveling to tie-outs.
- 9. All cattle must be out of the DEX and in tie-outs by 9 PM.
- 10. No livestock allowed in campgrounds.
- 11. All animals occupying stalls must be entered for competition and shows in their respective divisions.
- 12. Breeds must have a minimum of 5 head shown. If there are less than 5 head entered, they will show with All Other Breeds. No exceptions.
- 13. Registry certificates must be provided before animals can be shown in the ring and must be shown at check-in (written or electronic).
- 14. **GROUP ENTRIES**: Class numbers must be listed on online entry, but animals need not be named. Animals must be entered and shown in individual classes, and name and number of each animal given to the clerk when group is shown. Group classes must be pre-entered.
- 15. One member from any family, household, or business establishment may make entry in any Class.
- 16. Exhibitors will be required to keep their stalls and pens clean. Wheelbarrows will be available. FANS MUST BLOW TO THE NON-SHOW SIDE. Port-a-Cools are prohibited on State Fair property. Butt fans are not allowed in the DEX. They are allowed at tie-outs where electricity allows.
- 17. Tents are not allowed inside of the DEX nor in the outside areas surrounding the DEX.
- 18. Early release will be made available for legitimate purposes only. Exhibitors entered in another show will be required to show proof of entry to that show for early release.
- 19. Exhibits cannot be altered. Any animal or exhibit which shows evidence that artificial means, including but not limited to dyes, etc. were used with intent to deceive for removing or altering physical defects or conformation, shall be excluded from participation in any of the awards. Such exhibitor will be disbarred from participation in competition, and any awards or premiums previously awarded to the exhibitor will be withdrawn. The judge in each classification will have jurisdiction in the matter.
- 20. It is not necessary to make entries for champions. Cash award will not be paid for Breed Champions.
- 21. All female cattle 42 months of age must have produced a calf within the last 18 months to be eligible to show. Any bull over 36 months entered in any of the breeding classes that has not dropped to his servicing a living calf during the eight months preceding the opening day of the fair shall be deemed barren and as such, shall be excluded from competition. Certificates from exhibitors properly attested may be required by the superintendent.
- 22. Changes to the stalling assignments must be approved by superintendents.
- 23. It is required that each breed association furnishes their own ring steward for their show. Each breed show must show in a timely fashion and follow the rolling schedule.
- 24. The South Dakota State Fair has adopted and will enforce the IAFE National Code of Show Ring Ethics. A copy of this code can be found in the back of this book. All exhibitors will be required to sign an agreement to abide by this code when completing the online registration.
- 25. The South Dakota State Fair has adopted and will enforce an Animal Welfare Plan. A copy of this can be found at <a href="https://www.sdstatefair.com/participate/competitive-exhibits/open-class-livestock/">https://www.sdstatefair.com/participate/competitive-exhibits/open-class-livestock/</a>.
- 26. Livestock Trailer Parking: Livestock trailer parking is available at Huron Continental Marketing located west of Huron at 39763 US Hwy 14 or at the Heartland 4-H Rodeo Grounds located east of Huron at 2125 US Hwy 14.
- 27. On-grounds parking is prohibited without permits. Parking passes issued to campers are valid only for the campsites. They are not a valid anywhere else. If the vehicle does not fit within the boundaries of the campsite, the vehicle must be parked off grounds. Any vehicle found on-grounds without the proper credential for the area in which it's parked is subject to towing. There will be zero tolerance for parking violations; we will no longer be making PA announcements or giving warnings. Violators will be towed.
- 28. Fire Lanes: For safety purposes, any vehicle blocking a fire-lane will be towed at owner's expense.
- 29. The South Dakota State Fair has an electronic system at the gates for admission. All exhibitors must have an admission pass when entering the fairgrounds during the fair. It is recommended to purchase passes in advance to make for efficient entry into the fair. The majority of admission passes will have bar codes on them that will be scanned upon entry. Parking passes will be checked upon entry to the fairgrounds. Passes are only valid for the area and terms listed on the pass.
- 30. Duct tape will not be allowed on State Fair property.
- 31. **Sunrise Photo at the Fair**: Youth exhibitors who wish to take a photo with their animal on the Midway may do so on Monday, September 1, from 6:00 AM to 7:30 AM. During this time, select carnival rides will be lit with flashing lights to create a special photo opportunity. For safety reasons, this is the only time animals will be permitted on the Midway. Exhibitors must be respectful of the grounds by cleaning up after their animals and avoiding areas with food vendors or heavy foot traffic. Failure to follow these guidelines may result in forfeiture of premiums.
- 32. **Photography/Videography:** When you attend the fair, you enter an area where photography, audio, and video recording may occur. By entering the fairgrounds, you consent to such recording media and their release, publication, exhibition, or reproduction.
- 33. Straw bedding is prohibited for beef exhibitors.

34. **Woodchips:** Woodchips will be on sale at the Feed & Forage Buildings, supplied by Show Stock Bedding. All bedding pre-orders will be done through ShoWorks when entering exhibits online, on Page 3 (Items). The State Fair office will give stall assignments Show Stock Bedding to all those that have purchased bedding that is to be delivered to your stall before arrival. If you have questions on bedding, please call Dan with Show Stock Bedding at 605.695.2179.

- 35. Pumping or drenching of animals unless direct by a veterinarian is prohibited.
- 36. Substitutions are allowed and must be made by August 15. Please fill out the substitute form located in the back of this book and email it to Jeanette.Linke@state.sd.us or mail to South Dakota State Fair/attn. Jeanette Linke/1060 3rd St SW/Huron SD, 57350 by August 16. There is a \$10 fee per substitution (cash or check only).
- 37. Premium checks will be mailed to exhibitors within 60 days of the State Fair. If an exhibitor's earnings total \$600 or over, a W-9 must be completed by the exhibitor before their check will be issued. Premium checks for the amount of \$5 and under will not be mailed out (some exceptions apply). Affected exhibitors will receive instructions on how to collect premium winnings.
- 38. Please be considerate to all exhibitors and only enter the animals you plan to bring so we can plan accordingly for space.
- 39. Cattle must be tied in the DEX by 9 AM and out by 9 PM and cannot be moved to outdoor tie-outs before 5 PM. No cattle allowed in tie-outs 9 AM-5 PM without superintendent permission.
- 40. Any violations of rules may result in non-participation, disqualification, or dismissal off grounds.
- 41. **Livestock Release:** Livestock exhibitors will be released on Labor Day only at times designated by fair officials. The Superintendent for each species will issue a Livestock Release Form to exhibitors, which will state their assigned release time. Exhibitors must present this form to gate personnel at the time designated on the Livestock Release Form to be eligible to enter the fairgrounds to remove their livestock. Attempting to remove livestock before the assigned release time may result in:
  - Loss of premium, and/or

- 1. Late entries will be accepted until Tuesday, August 5th.
- 2. If you are planning to stall in the Open Class area and will have your 4-H steers stalled with you, you must signify on your online registration how many steers you will have. There is NO extra fee for stalling steers in the Open Class area of the DEX. This can be done on page 3 (Fees) of the online registration.
- 3. Open Class beef exhibitors have the option to stay stalled in the DEX through the entire fair or leave after the Open Class show period. Your final choice must be signified on your online registration. Those choosing to leave after the Open Class show may do so only after the completion of Supreme Drive until 5pm on Thursday, August 28. Those that are not gone by 5pm must remain in the DEX for the entirety of the fair. Exhibitor's choice to stay or leave can be done on page 1 (Register) of the online registration.
- 4. Outside Tie-Outs: Outside tie-outs will be located on the east side of the DEX in Lot D (east side of Nevada Avenue). All tie-outs will be pre-assigned. Exhibitors will exit and enter Gate 3.75 (east side of DEX) where there is a cattle-crossing guard: 5 AM–9 AM and 5 PM– 9 PM starting Wednesday-Monday morning. All cattle must be in the DEX by 9 AM and out of the DEX by 9 PM. Manure removal will take place between 9 AM-12 PM. No cattle allowed in tie-outs 9 AM-5 PM without superintendent permission. No loose pens are allowed in tie-outs. An exercise pen will be located on the southeast side of the DEX next to the Morton building. No cattle left unattended. Neck ties are highly recommended.
- 5. Camping: Open Class Beef Exhibitors that camp on South Dakota State Fairgrounds property will be allowed to begin their camping package on Saturday, August 23. Please signify if you camp on the South Dakota State Fairgrounds on your Open Class registration. #### AMERICAN ANGUS ASSOCIATION RULES

The American Angus Association<sup>®</sup>, 3201 Frederick Avenue, St. Joseph, Mo., will participate in premiums offered for open class Angus breeding cattle classes according to the premium schedule based on the number of head shown. The premium assistance provided by the American Angus Association for participation in this show is in addition to the premiums offered by the show itself. The premium assistance should not be used to offset show expense and shall be included in the premium payments distributed by the show to the exhibitors.

A minimum of 50 head must be shown in the open class division to receive American Angus Association premium participation for the following year.

Premiums from the Association are paid only to registered Angus cattle and only if the registration number is a part of the show report provided to the Association. Therefore, all Inscattle should be registered at the time of entry to make certain they receive the Association's portion of premiums. The Association does not pay on championship or any group classes, (i.e. get-of-sire, junior get-of-sire or breeder six-head).

Exhibitors must have the original registration certificate issued by the American Angus Association available for inspection at the show for each animal or another current proof of ownership issued by the American Angus Association pedigree look up. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks or hot-branded marks) corresponding to the permanent identification mark on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-identified (tattooed/branded) and rechecked at the show.

Any female shown with a calf at side: the calf must be the cow's most recent natural calf, and the calf must be registered by show day and have proof of registration at check in.

Only one person at a time shall lead an animal into the show ring.

Exhibitors who participate in shows that accept premium monies contributed by the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2: Association Rules. The rules relating directly with the exhibition of Angus cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800 - 810. These rules can be found at www.angus.org.

Altering the conformation and/or appearance of an animal for exhibition is prohibited. This includes the use of chin straps, covering of white skin, false tail heads (or use of any false hair), except for false tail switches. The use of graphite, powders, hemp, or other similar substances used externally are also prohibited. Other prohibited products include those used internally such as steroids, illegal or unlicensed pharmaceuticals or artificial filling. Any animal found to be in violation will be barred from showing.

At any show for which the American Angus Association appropriates funds toward the payment of premiums, no exhibitors, individuals assisting exhibitors or member owners at such show shall be allowed to use any coloring agents, on any animal exhibited. The Association may adopt and implement various tests designed to monitor this prohibition, including but not limited to a "white towel" or "white glove" test. No aerosol cans or other pressurized containers will be allowed in designated line up

All animals exhibited are subject to DNA marker or blood type test to verify accuracy of parentage as covered under the Association Rules and for other testing as required by the individual show.

Authorized representatives of the Association have the authority to enforce the rules set forth herein as well as in the Association Rules, including the barring of a registered animal from a livestock show at which it is to be s Any classes listed in this classification, which exceeds 15 head per class, should be broken into smaller classes. This should be accomplished by dividing the class as evenly as possible without splitting animals with the same birth date.

Furthermore, the recommended number of head per class varies per show based on number of head checked in. See recommendations below:

--Shows with less than 100 head: 8 head or less per class; Shows with 100 – 200 head: 12 head or less per class; Shows with more than 200 head: 15 head or less per class.

Class breaks will be at the discretion of the American Angus Association staff in attendance.

If there are more than 30 head in a division, the division should be split into Division 1, 2, etc.hown, if there are reasonable grounds to believe a violation has occurred.

Only registered Angus cattle that meet the age requirements listed within this classification are eligible to receive premium participation and be counted in the total number of head shown. Champion and Reserve Champion placings are not counted in number of head shown.

#### **Special Rules**

All animals to be eligible for an Open Charolais Breeding Division must be purebred and registered with American-International Charolais Association (AICA). Only bona fide (original) certificates of registration will be accepted as evidence of registration and ownership—photocopies will not be allowed.

An animal is eligible to enter or compete in an open Charolais breeding class if registered in country of origin outside the United States and is eligible for purebred registry in the AICA Herd book.

All animals to be eligible may be approved by a Sifting Committee designated by the AICA. Stall space will not be provided for any Charolais cattle that have not been accepted by the Sifting Committee.

All animals are subject to a medical examination to determine age, and each animal will be presented in the show ring in its natural conformation without alteration or modification. Use of artificial tailheads not permitted.

Any animal not having a legible tattoo or firebrand number is ineligible and will be barred from showing.

Bulls from Classes 13, 14, 17, 18, 19 must have a valid, satisfactory semen test certificate in possession. This certificate is valid for the entire show season.

All animals shown in individual classes must be weaned, with the exception of the Cow-Calf Class and calves at the side of females calved after September 1, 2023. Calves at side must be purebred and registered with the AICA. Females calved after September 1, 2023, must show in individual female class appropriate to age. Nurse cows are not permitted.

All females 20 months and older exhibited at AICA - sanctioned shows must be accompanied by a certificate of pregnancy from a licensed veterinarian or have produced fertile eggs as certified in a written statement by a licensed veterinarian or embryologist or have a calf at side.

AICA requires that all animals be shown with a halter and suggest that all bulls be shown with a nose lead.

ALL EXHIBITS OF CHAROLAIS BREEDING CATTLE SHALL BE GOVERNED BY THE AICA RULES AND REGULATIONS, ARTICLE XV, TITLED EXHIBITION OF ANIMALS. THE INSPECTION OF EXHIBIT CATTLE IS SPECIFIED IN ARTICLE XV, PARAGRAPH C, OF THE ASSOCIATION RULES AND REGULATIONS AND NON-COMPLIANCE OF EXHIBIT INSPECTIONS SPECIFIED IN PARAGRAPH D OF THE SAME ARTICLE XV.

ARTICLE XV, PARAGRAPH B, POINT 2: "Each animal will be presented in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical or other (including banding or other circulatory constriction) appearance change for cosmetic purpose, save only branding, tattooing, foot trimming or dehorning. The act of artificially filling animals internally which would include stomach pumping, drench tubes or any other method per so (by esophagus) is prohibited. Silicone injection or other injection for cosmetic purpose shall be prohibited. Anabolic steroid use shall likewise be prohibited, and any animal testing positive for anabolic steroid or diuretic use shall be presumed to be altered and modified."

Effective October 22, 2004, at any American-International Charolais Association (AICA) sanctioned show (including shows receiving AICA premium funding and/or qualifying as a Roll of Excellence Show), the use of a coloring agent, flock and powder is prohibited. Use of these products will result in the immediate disqualification of a given animal at such a show.

Where circumstances exist and/or allow, AICA reserves the right to split large individual classes after the check-in procedure is complete.

Following NALF and NALJA rules, a Lim-Flex animal must be registered, and proof of registration must be shown with the NALF's purple registration papers.
- 4. All animals must be properly recorded and in the name of the exhibitor by the entry deadline of the given fair or exposition. Cattle must be entered in the exact same name that appears on the registration certificate as the current owner.
- 5. All animals must be properly tattooed and will be inspected at the show. Tattoos must be legible and must properly match the registration certificate.
- 6. To maintain a high degree of confidence in Limousin shows, the North American Limousin Foundation (NALF) reserves the right to disqualify any animal that has been fitted in an unethical manner. Unethical fitting shall include the following:
  - a. Any altering of the natural color of the animal by use of dyes, paints, hair coloring conditioners, colored show foam graphite, colored powders or any other substance.
  - b. The addition of any hair or hair like substances, including false tailheads and false polls. False tail switches are allowed.
  - c. The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue to alter the shape of the animal.
  - d. The injection of any gas, solid or liquid under the hide to alter the normal conformation.
  - e. Any attempts to disrupt or change the normal dental development of the animal.
  - f. Any products/solutions/liquids administered internally or externally to alter the conformation of the animal is prohibited.

This includes the use of steroids, growth promotants and the act of artificially filling animals internally, which would include stomach pumping, drench tubes or any other method per so (by esophagus).

Exceptions: In the case of severely sick or severely dehydrated animals, the exhibitor may have fluids or electrolytes administered by a veterinarian or NALF representative. This exception is not applicable on show day or weigh-in/checkin day.

- 7. All aged bulls must show with a nose-lead. The right to disqualify from the show any animal deemed unmanageable is reserved by the Limousin show superintendent and the show management.
- 8. All protest against exhibitors or individual animals dealing with the age or genetic background of show cattle must be submitted in writing and signed by five lifetime members of the NALF and presented to the show superintendent within 12 hours after the completion of the show.
- 9. The NALF reserves the right to mouth animals for dental development at any show sponsored by the Foundation.
- 10. There are no limitations as to color or color markings of Limousin cattle shown.
- 11. It is recommended that if 15 or more head are entered and checked-in in any single class, the class shall be split into two equal Classes as determined by age.

- Exhibitors are subject to all rules and regulations of the American Maine Anjou Association (AMAA). When
  entry is made, exhibitors agree to abide with the rules and regulations established by the AMAA as well as
  the rules of the show management. Entries found to be misrepresented, or persons not abiding by the show
  rules, may be disqualified from showing.
- 2. All animals must be registered in the AMAA and the original certificate (or an application for registration with a check for fee) is required for presentation before the show. Electronic or hard copy.
- 3. Tattoos will be checked, must be legible, and correspond exactly with the registration certificate (or application for registration). Other than Brucellosis Calfhood tattoo, there shall be no other permanent identification marks other than those noted on the certificate of registry.
- 4. The attempted surgical or non-surgical alteration of conformation of an animal is prohibited, except for dehorning. Cattle are to be shown in their natural conformation.
- 5. The use of false tailheads or adding hair, or other material to any part of the animal's body is prohibited.
- 6. The dying or artificial changing of the existing color pattern and color will be prohibited.
- 7. All animals over seven months of age must be dehorned.
- 8. All cattle shall be made available to have blood drawn for parentage verification and/or detection of foreign substances.
- 9. Bulls 10 months of age and older shall be shown with a bull lead in place.
- 10. Heifers exhibited at 20 months of age or older must be accompanied by a certificate (available for inspection) of positive fertility issued by a licensed veterinarian.
- 11. Bulls exhibited at 14 months of age or older must have had a positive semen test, and a certificate to that effect must be available for inspection.
- 12. All cattle shall be made available for veterinary examination to determine the presence of altering. Cattle also will be made available for veterinary examination to be mouthed for age verification. The Show Committee reserves the right, after mouthing by a qualified veterinarian, to remove an animal from the show or designate the animal to be shown in a different Division from that previously entered, at the Committee's discretion. An animal shall remain in the same Division as placed in at time of mouthing for the remainder of the show season, considered to be June 1 to June 1. The exhibitor shall have the opportunity to have the animal(s) remouthed at his own expense for future shows. The selection of the individual to do the remouthing shall be at the discretion of the AMAA Show Committee.
- Exhibitors shall wear show harness to exhibit entry numbers and performance data cards for all AMAA sponsored shows.
- 14. The Maine Angus will show under Maintainer until enough entries warrant a separate division.

#### IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1) All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- 2) Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- 3) Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4) Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event.

If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian. (continued on next page)

- 5) Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6) The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- 8) No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
- 9) The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- 10) The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expos and any special notices to members.
- 11) The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
